#### From the Head of School

This Annual Report from 2022-2023 reflects God's abundant blessing on Trinity Oaks Christian Academy. Throughout the admissions season leading up to the school year, it was evident that God was orchestrating the school year to be one of abundant blessings. By the end of the 22-23 school year, we had welcomed a total of 70 new students from 36 families.

Abundant blessings meant an abundant enrollment for the 22-23 school year. We concluded the school year with an enrollment of 299 students which is the highest ever enrollment! We also were blessed to experience our highest ever retention rate. This growth was welcomed as we filled more of our classrooms and split several grade levels for the first time. We continue to stand amazed at the Lord's faithfulness to Trinity Oaks throughout this period of growth. Amidst the changes, Trinity Oaks continues to provide a caring environment, academic excellence, incredible teachers, and most importantly, a Christ-centered, biblically based curriculum.

On August 1, 2022 we closed on the purchase of our building we call home at 233 Trinity Oaks Way. For the first time, Trinity Oaks has a monthly mortgage payment as opposed to a monthly rent bill. This dream of owning our permanent home has been decades in the making and was only possible through the faithful prayers, gifts and work of countless TOCA supporters. We were thrilled to make this building our permanent home as our roots grow deeper and deeper in our community.

The Annual Report reflects our desire for financial transparency as we endeavor to exercise faithful biblical stewardship of the resources entrusted to us. We recognize that all the funds available to us come from tuition or donations. We want to provide the information necessary to promote fiscal confidence among all our stakeholders and ministry partners.

The TOCA Board of Trustees receives a compilation report each quarter from an independent accounting firm as a part of their fiduciary responsibilities to provide financial oversight for the school. A copy of the compilation may be reviewed in the Head of School's office. The school budget is carefully designed to provide the maximum benefit to the students in the most efficient manner. Donors can be assured that funds contributed to TOCA are spent as promised by the school in accordance with the intent of the donor.

The generosity of the Trinity Oaks community never ceases to amaze and inspire us to press on in the fulfillment of our mission and vision. We are so grateful for the financial generosity of our current and past parents and grandparents, faculty, staff, students and other financial supporters of our school. We continue to see God's hand of provision and are appreciative of those who have invested in the lives of not only the students of today, but also in the lives of those students who will walk these halls in the future. We humbly recognize that we could not meet the needs of the school without your faithful giving.

It truly is a privilege to be provided the opportunity to partner with you in training up your children and to help carry out the mission and ministry of Trinity Oaks Christian Academy. 

















































#### 2022-2023 ANNUAL REPORT






## **FINANCIAL REPORT**

### **REVENUE AND CONTRIBUTIONS**

Operating a thriving Christian school like Trinity Oaks is expensive. Our needs exceed revenue from tuition and fees – especially when it is a priority to make a concerted effort to maintain modest tuition costs allowing us to attract more families. That means Trinity Oaks counts on the giving of a community of ministry partners – those who provide faithful support to the school year after year. The following information reflects heartfelt generosity to keep Trinity Oaks on the the forefront of educational distinction.



#### **EXPENSES**

We feel people are our greatest asset. The staff is well-qualified and committed to ministering to the hearts and minds of our students. The majority of our expenses are expended in compensation of staff along with building and operating costs.

### **BUILDING PERMANENCE FUNDS**

For the first time in the history of Trinity Oaks Christian Academy, we have a permanent home at 233 Trinity Oaks Way. After leasing our building for the past 10 years, God has richly blessed us with the opportunity to officially purchase our school home in June 2022. We are deeply grateful to previous Board of Trustee members and their astute negotiations with the Cary School District. As a result, we were able to use \$750,000 in lease payments made against the purchase price of the building.

### **EMPLOYEE RETENTION CREDIT FUNDS**

Trinity Oaks was able to work with a local accounting firm to apply for and receive Employee Retention Credit (ERC) funds. The Employee Retention Tax Credit or ERTC – is a refundable tax credit for businesses and tax-exempt organizations that had employees who were affected during the COVID-19 pandemic. These funds were used to help Trinity Oaks attend to several of our many deferred maintenance projects as itemized below.
